- The TEI's major expenditures (shown in order of cost) reflect appropriate prioritization, in your Treasurer's view.
- The TEI's institutional membership numbers are down and our individual numbers are up, and that's been the trend for the last few years.
- The TEI's balances by quarter are holding steady vs. FY2014
- The TEI's average annual balance in the current year to date is up \$80,000 vs. 2012, when we moved to Wild Apricot, automated billing, and PayPal payments as an option.
